If covered, the dealer will flush the entire brake system with a new fluid [H-D Platinum Label DOT 4 Brake Fluid] using Digital Tech II. Owners will also be reminded of the 2-year maintenance cycle specified in the Owner's Manual.
	As noted, this condition is associated with delayed or neglected brake fluid maintenance as specified in the Owner's Manual. Harley-Davidson does not intend to reimburse owners under its Reimbursement Program for costs incurred related to prior brake fluid flushes. However, Harley- Davidson is offering the remedy fluid flush (using the new H-D Platinum Label DOT 4 Brake Fluid) free of charge to all motorcycles within the recall population, regardless of their maintenance history.
